Notice Concerning Dividend of Surplus

HASEKO Corporation (the "Company") hereby announces that it has resolved, at a meeting of the Board of Directors held on June 27, 2024, to pay dividends of surplus with a record date of March 31, 2024. The details are described below. As a result, the annual dividend for the fiscal year ending March 2024, including the interim dividend (40 year per share), will be 85 year per share.

The Company's basic policy is to promote strategic growth investments, enhance shareholder returns, and continue to pay stable dividends while maintaining a strong financial base. Based on this policy, the Company has revised the year-end dividend to 45 yen per share up 5 yen from the previous forecast, taking into account our business performance for the fiscal year ending March 2024.
